Complaint

It's official. I am God! Don't call the Looney bin. Simply file perjury charges on me if you think I'm wrong.

Here's my story - www.mytrumanshow.com.

I sued David Copperfield, simply making accusations about godly powers. I found out, under oath, I was right. He's got my godly powers. So then I sued Joel Osteen with accusations, similar to below, to find out what he's thinking under oath. I found out he thinks that I'm God, but doesn't want to give me any tithing because there's no law to compensate God for tithing. Joel is so generous. Joel is out of state and MN lacks personal jurisdiction, but I found out some important information. So I am conducting a test, forced to sue local churches to get money. But I'm not suing for tithing. I'm suing for tort for fraud (deceit - intentional misrepresentation) compensation.

What's happening is very complicated. It turns there's this guy - we can refer to him as Satan. He's been around for over 5000 years, during Jesus days. Don't call the Looney bin. Simply file perjury charges on me if you think I'm wrong.

Anyways, he has built up a network of deceit centered around the religious

industry. I estimate over 90% of all church leaders are working for him directly/indirectly. Joel Osteen is one. Joel knows I'm God, but falsely preaches crap from the Bible as the word of God, even though he knows that www.mytrumanshow.com is the word of God. He knows Chris Roller's life is the journey of God.

So this is very simple for the church, to avoid this lawsuit. All you have to do is tell me under oath that you don't believe Chris Roller is God. In addition, submit information, under oath, of the word of God. You can submit the entire Bible (revision # reference, not the actual Bible please) if you wish. Now I'm not saying you need to submit the Bible with the intent that is the exact truth, but only that you believe it's true. It's called faith. Key thing here is - faith preference. I allege I am God/Messiah, the only God/Messiah, the one and only. But if people wish to believe that something else is God/Messiah, like Jesus of Nazareth, or your neighbor, or David Koresh, simply state it. That's freedom of religion and I have no problem with that. Believe what you want. But if preachers believe that Chris Roller is God/Messiah, then we have a major case of fraud because they are preaching falsifications at their church.

The fraud has caused me a lot of pain and suffering, and loss of money. People should be tithing in Chris Roller's name, to his church, his followers, if the preachers were honest and not corrupt. Chris Roller has no following, no church, no believers, no friends, no money, no house, no family, all because of this alleged fraud.

God=creator of the universe, guiding our actions via God's plan, around since the beginning of time (big bang).

Messiah=symbolic name for the entity representing God. Chris Roller also states he is the Messiah, the savior, representing God for the good of humanity.

Like many religious sects, I assume God and Jesus/Messiah are considered the same. I might find out under oath that I'm not God, but Messiah, acting role for godly powers on planet Earth. As I understand, I have over a million children via immaculate conception. I think this would qualify as proof that I'm God. I've initiated over a dozen lawsuits now, and despite begging for a statement, and no one has told me I'm not God yet. People do this willingly (and slam it down my throat) outside the courtroom though. No one has yet to make this statement under oath, where the whole truth and nothing but the truth will be told. By the way, I believe the courtroom is supernatural, making people tell the truth under oath, especially if it's supernatural/godly. It's my magic trick. It's the only way Copperfield would ever fess up to godly powers. This godly stuff is real in the courtroom. Outside the courtroom it's a different story. It's very complicated, the merging/separation of reality and unreality.

I also estimate over 75% of all lawyers and 50% judges are working for Satan (literally the Devil's advocate). So I have my suspicions when I enter the courtroom, afraid that decision-making (judgments) are being skewed away from me.

Here's my statements of allegations that are true unless the defense denies the statement.

Make some statements in the reply to the above, otherwise my statements are undisputed, and thus the truth, and thus claims for relief.

I just need these admissions in the reply, a submission in a declaration by the defense.

1. Leaders of [Church] does not believe Chris Roller is God/Messiah.
2. Leaders of [Church] does not believe Chris Roller is the Messiah.
3. Leaders of [Church] does not believe Chris Roller's life story (www.mytrumanshow.com) is the word/story/journey of God.
4. Leaders of [Church] believes that _____ is God/Messiah.
5. Leaders of [Church] believe that _____ is the word of God.
6. Leaders of [Church] have never heard of Chris Roller until this law suit was commenced.
7. Leaders of [Church] became aware of Chris Roller as God/Messiah on the following date _____.

If item 1/2/3 is stated, this case is pretty much history, and I drop it. This case is very simple. No lawyers needed. No legal ramblings and runaround please. Just make the statements. It's nothing personal against the church. I'm just trying to get some answers to what you "really" believe, all while getting some money due to God. If you're mad at me, don't be. If Joel Osteen or his lawyer had told me,

"Joel Osteen does not believe Chris Roller is God", this case would never have been filed. And the only way to survey churches of the truth is via the courtroom, thus a law suit.

This case is joinder. Based on the responses, if churches think I'm God, it will move to class action defendant class for all churches in the area/state.

Amount is undefined. Millions perhaps. Discovery/reply will show the date they became aware that I was God and the fraud commenced, and thus the damages. With no date provided, I will assume 1 June 1985, when my show approximately started.

Federal fraud is USC 18 § 1038. Statute of limitations is 6 years in Mn. per MN § 541.05 from discovery of the fraud.

CONCLUSION
