Memo in Opposition to Motion to Consolidate/ Dismiss/Sanctions

ARGUMENTS

Case 07-1296 is a patent infringement case. Per U.S.C 28 § 1338, Minnesota Federal court, the home of the patent, has exclusive jurisdiction. Personal jurisdiction is incorporated as part of the "exclusive jurisdiction". I do not have to pursue people in their home state for infringing on my patent. I oppose the motion for consolidation of cases.

14. JREF has never contacted Minnesota Skeptics or Robert W. McCoy for the purpose of investigation of paranormal claims submitted via the JREF Paranormal Challenge.

15. JREF has never contacted St. Kloud ESP Teaching Investigation Committee (SKEPTIC) or Jerry Mertens for the purpose of investigation of paranormal claims submitted via the JREF Paranormal Challenge.

16. James Randi Educational Foundation has never had any Minnesotans challenge the JREF Paranormal Challenge.

The above missing statements, means the opposite, means he has contacts in Minnesota - more than enough to qualify as minimum contacts. Thus, I oppose the motion to dismiss because JREF has minimum contacts in Minnesota and because the challenge is a global contract, not simply for Floridians.

CONCLUSION

For reasons stated above, I oppose the motion to dismiss, motion for consolidation, and motion for sanctions against me.
