Memo in Support of Motion for Partial Summary Judgment

ARGUMENTS

Judge Jeanne Graham, I have made a blunder. I wish the patent laws were clearer. I do have provisional royalty rights for infringement, but I just don't get to collect until the patent issues (collect for the past dues). Thus I do not have a case for patent infringement claim at present. I feel silly.

So what am I going to do now? I have no claim, or do I. I have a few things going for me - I'm God, I cannot be killed, and many have tried, and only the truth will be told to me under oath.

I've got a few thing going against me too. It's amazing/bizarre that no one will give God anything so I can live a better life. I'm making the truth happen under oath and no one compensates me. I should get church tithing and credit for the Universe and everything supernatural. Instead everybody tries to kill me. Joel Osteen (07-1296), religious preacher, admits I'm God, and yet doesn't want to give tithing to me because of greed and because there's no law setup for God tithing compensation. Also, he's actually a demon working for Satan (western MN) and

really could give a crap about God, such that he attempts to kill me. What a hypocrite world I'm taking on. David Copperfield's using my powers and doesn't want to compensate God for those powers. Wow! Although Copperfield is my child, is he also working for Satan? How do I get ahead? I'm left no choice but to seek the truth to see if Copperfield tried to kill me.

I asked for statements denying the allegations, otherwise the opposite is true. It was very simple task, but I saw no acknowledgement of my questions, thus the inferred allegations, and thus the hit conspiracy against Chris Roller exists.

I asked to see a statement stating, "David Copperfield never conspired to kill Chris Roller shortly after his phone call to Chris, on 26Apr2005."

There is an undisputed allegation that the David Copperfield attempted to kill Chris Roller. One memorable attempt was 26Apr2005. David called on the phone to try to talk me out of my first suit against him in 2005. When I refused, he had his thugs try to kill me, shortly after the phone call. "David Copperfield has never attempted to kill Chris Roller." If the statement appears, then it's the truth, and I will rescind this motion. Otherwise, the statement cannot be made because it would be a lie, and thus the hit occurred, and the fact remains undisputed, and this is the evidence needed for partial summary judgment in the amount of \$trillion. This would also qualify as a claim for relief, and I would oppose the motion to dismiss.

I would again oppose the motion for sanctions. I may have made a mistake with the patent claim, but as can be seen, the patent provisional rights laws are confusing. Also, I may have a valid claim with this motion (based on response/lack of). I'm trying to solve problems myself because I can't hire a lawyer - they won't touch me because of this godly subject matter.

CONCLUSION

For reasons stated above, Chris Roller is asking for partial summary judgment in the amount of \$1,000,000,000,000 (\$trillion). Also I oppose motion to dismiss and sanctions for reasons stated above.
