Memo in Support of Motion for Miscellaneous Relief - "Truth under oath"

I need relief, and it's not the kind Alka Seltzer can cure.

It seems amazing that I/God have to get a patent and sue people in order to get any money. Or sue people to get any answers under oath.

I have a patent pending which essentially states that reality revolves around Chris Roller - I am the reason for reality in the universe. This is very bizarre and will require some research to prove - research and experimentation under oath via the relief I'm asking. I'm also considering a patent on the "Truth under oath" soon.

I think the world is very weird, and very complicated, and I, as God, want to know the truth. Here's the problem. The truth of the weird/supernatural is only accessible under oath, a supernatural medium. Outside the courtroom (OC), I'm considered crazy and not God. In the courtroom (IC), I'm completely sane and indeed God. Outside the courtroom (OC), many people are lying horribly about many things, for example, insisting the supernatural does not exist, yet it indeed exists, and it's very weird. If I were to show this document or my cases to a

psychiatrist, OC, they would lock me up and throw away the key (and probably try to kill me in the process. Most psychiatrists are demons). Currently, the only way to do this is to sue people, but the judges seem to ignore everything I submit, and then dismiss my case, calling what I'm doing frivolous, giving me sanctions in the process. Um, I'm God, people. What is suppose to happen is the judge confirms what I'm showing, that people are trying to kill me, and then issue an order to the Attorney General so criminal prosecution can begin. But Chris Roller, aka God, is being disrespected and ignored.

Currently, the only way to oath is to sue people, but people don't like to be sued, and demon attorneys working for Satan love to sanction God for trying to get to the truth. What I need is a way to interrogate people without having to sue them. It takes months to get a law suit to mature. In the meanwhile, this is enough time for thousands more attempts on my life to occur. Then ironically, the case gets dismissed. Apprehension of alleged activity needs to take place within hours, not years. Right now, there is little deterrent for my demons trying to kill me because there is no solid evidence. When I go out to a restaurant and I notice people/ demons are trying to poison my food, I would like to call the Attorney General hotline and report this crap, and commence interrogation of this activity in hope that it will finally stop (deterrent).

I am God, key creator of the court forum, making the truth happen under oath. I deserve some special privileges in the courtroom, not sanctions. I'm showing, via my cases this year (07-1182 GNE/JJG, 07-4069 JMR/FLN, 06-04702 JRT/FLN, 07-1296 JRT/FLN, 07-1298 JNE/JJG), that people are not denying my accusations of trying to kill me. Instead the defense issues a run-around in the case to avoid the ugly truth and get it dismissed, and then the judge goes right along with it. My accusations remain unanswered and ignored. I have the right to feel safe in this world. I need the relief I'm asking for. I don't think I'm wrong when I say, over one-third of the country has conspired to kill Chris Roller. My life is in danger, and to get it stopped, we need to get people in the courtroom, under oath, and interrogate them, right away, not months/years later, to act as a deterrent. When I say my life is in danger, I'm talking about virtual danger. Because I have another magic trick that keeps people physically in check, and other magic remedies, I'm safe. But I am utterly sick of seeing the hit attempts and I want it to stop now.

The only way the Attorney General can file criminal prosecution is via referral from the police, FBI, CIA, etc, or Judge order. I have tried the police (OC-crazy) and FBI (OC-crazy), but they need more solid evidence. The evidence I've shown in my federal cases this year (07-1182 GNE/JJG, 07-4069 JMR/FLN, 06-04702 JRT/FLN, 07-1296 JRT/FLN, 07-1298 JNE/JJG) is solid, via the truth under oath, showing the hit attempts without denial. The evidence is the truth, using a simple interrogation under oath. If someone stole from my apartment, and then sold it all, all the evidence that remains is the truth under oath. I want to bring the accused under oath for a simple interrogation. Under oath, via Chris Roller's very impressive magic trick, the truth will come out.

The relief I ask is a special privilege due God. I demand credibility to all my crazy accusations, and ask to respect the things I do and not call my actions frivolous, like I'm some kind of trouble-making peon. I am God, indirect creator of the universe. I need to ask people questions under oath, to get to the truth. This will be done in conjunction with the Attorney General. As this, I'm asking for payment for the truth, to be put on the federal payroll, a job/position like "God, supervisor of the truth in federal courts". Chris Roller is also asking for direct access to the court/judge/oath/Attorney General (a hotline) to help interrogate/question people under oath, right away (within hours), instead of having to sue in a time-exhaustive civil run-around.
