Per MRCP Rule 15 (a), "A party may amend the party's pleading once as a matter of course at any time before a responsive pleading is served".

Wagner, Falconer & Judd (WFJ) is the representative in MN for Prepaid Legal. The other defendants, party with WFJ to a conspiracy on the darkest level. This is a conflict of interest, attempted murder, and mollestation, cases all against the defendants. The judge is probably going to be unhappy when he/she sees this. God is also unhappy. That's me, Chris Roller, Jesus/God/Holy Spirit, under penalty of perjury. Make note of this please, as this statement of fact, as this is what creates the hatred and conflict of interested associated with the felony behavior of the defendants in this case.

There was a lawsuit in Hennepin County a year ago, small claims against Bosley. My hair transplants did not work - Bosley offered to pay \$5000, \$600 short of the required amount. I

made a counter-offer for the proper amount. They denied that. I had to sue them in small claims in which Judge Boris immediately said case dismissed. I had a problem with the post office with my universal stamp, a short-cent mixup which prevented me from filing my appeal with the District Court in a timely manner. I've been trying to figure out what occurred in the case. I later realized that there was a been a huge conflict of interest with the attorney for Bosley, WFJ, Judge Boris, and administrators of the Burnsville post office for interrupting my quest for legal justice.

Tracing back, during my three years with Prepaid Legal, I've asked politely if they could help me out in my legal endeavors. When they got wind of David Copperfield case, Dan Smith told me I had no chance of winning and shame on me for even attempting to do so. Shame on me for attempting to bring to light something very important in this world called godly powers and shame on me for trying to get compensated for the use of godly powers and magic shows which produce solutions that defy explanation. Heaven forbid, I get compensated for being God, which I am, under penalty of perjury. Within the first month of WFJ, and inquiring about DC lawsuit, Dan Smith is upset at what I'm doing. Dan Smith c/o WFJ had conflict of interest me ever since I started with prepaid legal. During my endeavors over the three years with them, I would run into roadblocks...

1. If I asked for free help pro bono from Dan Smith and WFJ, which they give people for some cases, they of course didn't have any openings for me, and of course wouldn't have openings for years. There was always an answer of "No Chris" or "that's probably not going to work" for anything that could help me.
2. Constant arguments with Dan Smith aimed at keeping me down, preventing me from winning, and criticizing everything I do.
3. Dan Smith states "You need to stop bothering people, Chris!", or "in that other case, they have a claim for relief, but you, Chris, you do not have claim for relief, in any of

your cases.

4. Concerning Bosley, the last conversation with WFJ indicated there is no need to escalate the negative judgment from small claims court to District Court, as judges always decide the same way - appeals are unnecessary. Wow, what an idiot Smith is! And that's a fact, not an allegation, under penalty of perjury.
5. The intensity of runaround in Dan Smith's voice was immense. There was no doubt that WFJ should not be representing me.

When I sued General Electric in 2005, WFJ had a conflict of interest because they represented GE. So WFJ is allowed to get out of the way and refer me to somebody else when there is a conflict of interest. But if WFJ has a conflict of interest with me in general, they should not be consulting me. I've lost many cases as a result of the fraud, suing for \$trillions.

During the last moments with Prepaid Legal, I had my problem with Bosley small claims case. I tried seeking some other legal help from another law firm. In a few days, the law firm sent me a letter stating they could not represent me. There was a conflict of interest - the same conflict of interest that WFJ has with me - for the entire time I was with Prepaid legal. During the process there has been some sound advice coming from the lawyers from WFJ, but not Dan Smith, the chief lawyer at the firm, whom I talked with almost 50% of the time.

During the years, there has been several attempts on my life that resulted in real-world side effects. One was Lisa Nowak from NASA on 06Feb2007. Another incident was the Virginia Tech shooting on 16Apr2007. For these two incidents and at least one more, Dan Smith, was involved in the assassination attempt in the conspiracy to kill Chris Roller. Then Dan gives me advise on how to proceed with these hit attempts, trying to remedy his assassination attempts, advise guaranteed to lose courtesy of Dan Smith. Alexander Gese has also been part of these plots to assassinate me.

These are facts. The defense can file perjury charges on me if I'm incorrect. I'm under the impression that my daughter has been molested by Dan Smith, Alexander Gese, and Mark Boris during the past year, sometime, somehow, somewhere.

WFJ will longer honor a new membership with prepaid legal because there is a conflict of interest. For many reasons as I've explained there is a conflict interest with Dan Smith and WFJ and Prepaid Legal in dealing with Chris Roller. They should not be giving him advice when the intent was to lose - always hoping for the worst, while giving bad intentions and bad advise for Chris Roller. I'm suing WFJ c/o Dan Smith for conflict of interest with me. He should not have represented me in my quest for knowledge in my legal endeavors for which I lost all of them worth \$trillions. I'm suing for the continuous attempts to assassinate me via Dan Smith, and for molesting my daughter by Dan Smith. I state for a fact that defendants did all this, and the defense can file perjury charges if I'm incorrect.

I have found in my legal endeavors that I could accuse my defendants of heinous felonies, and I get no answers in return. It has been a very frustrating struggle in my legal endeavors to get to the truth on this planet. It turns out that they are collaborating together to end any success and prevent any justice from happening on this planet for Chris Roller.

And it's hard to prove this other than stating the truth, that there is a conflict of interest. I later realized what that conflict of interest was. That each of those parties involved in the case thought it necessary to molest my daughter, as a means of punishing me, and then rub it in my face to dismiss the case by the offending parties (defendants). My daughter is being molested by the parties involved in this case, including Dan Smith, Alexander Gese, and Honorable Judge Mark Boris.

Now I have found in my legal endeavors, for the parties involved, to just completely ignore everything I submit. And the judge the same. Felony attempts of conspiring to end my life. And now, I'm accusing people of child molestation. I would like to know that this is happening or not. I'm hoping that this lawsuit, and documenting it publicly in a blog, that there can be a least discovery attempted to find out if this is actually happening. And by the way, when I say these things are happening, I'm stating facts, under penalty of perjury, that if these statements come back from the defense, indicating that this is not happening, you can file perjury charges on Chris Roller. I'm getting tired of alleging and finding out nothing, so I'm now stating accusations of fact to prove my point.

I'm publically documenting this lawsuit because I want my audience to understand what happens in the lawsuit step-by-step. And I realize that this is probably going to get dismissed as usual, but at least my audience can understand the process, and the subsequent dissonance, and how little things get done in the legal system. I'd submit felony behavior and the defense comes back saying, "judge we want this dismissed" and the judge says "sure", and Chris Roller gets nothing accomplished in the legal system because nobody wants to answer questions of felony behavior.

I know I sound like a pessimist but I'm actually hoping this case proceeds to something more fruitful. I would like answers to these felony accusations, and to get compensated for the conflict of interest that prevented me from seeing justice. I'm hoping that by documenting this lawsuit for the public, that some answers get resolved.

I've asked prepaid legal and WFJ, and Judge Boris, under threat of lawsuit, for statements outside the lawsuit about a conflict of interest. They denied my simple and no-cost request. I now know why the conflict of interest exists. It's because the parties involved are molesting my children. I would like this addressed in the name of truth and justice on this planet. I would

like to know that I'm safe in this world that my children are safe.

I get very frustrated when I, a disabled war veteran, spends \$500 in lawsuits and the only thing that occurs from the case is "Chris Roller is frivolous". And I find nothing frivolous about felony behavior of attempted murders and molesting my children.

To the judge, please do not dismiss this case. Let this case go to discovery, so that we can get some answers resolved or perhaps, heaven forbid, in the reply, maybe the defense would actually indicate that these felony acquisitions are not actually happening.

I want justice on this planet. The first part of justice is getting truth, and you've heard it - I've mentioned 100% truth in this document, under penalty of perjury. This truth that means there have been violations for which claims I stated should seek financial remedy. I'm suing WFJ, and each of the parties involved, for \$1 trillion for fraud (conflict of interest), attempted murder of Chris Roller by the defendants, and the molestation of my daughter by the defendants.
