**Narrative Report:**

On 08-29-2011 at 1325 hours the Secretary of the Redwood Falls Police Department, Sandy Davis, told me there was a call parked on line one for me and that the caller was Christopher Roller. I answered the phone by asking "can I help you". Mr. Roller identified himself and stated I should know him because he was in jail approximately two and a half weeks ago. He went on to say he was in jail because my wife, who works at the courthouse, put him there. Mr. Roller feels her goal was to put him there. I interrupted Chris by saying "Chris, I do not want you calling me or my wife ever again" and at this time the phone conversation came to an end when I hung up the phone. The phone call was complete at 1327 hours.
